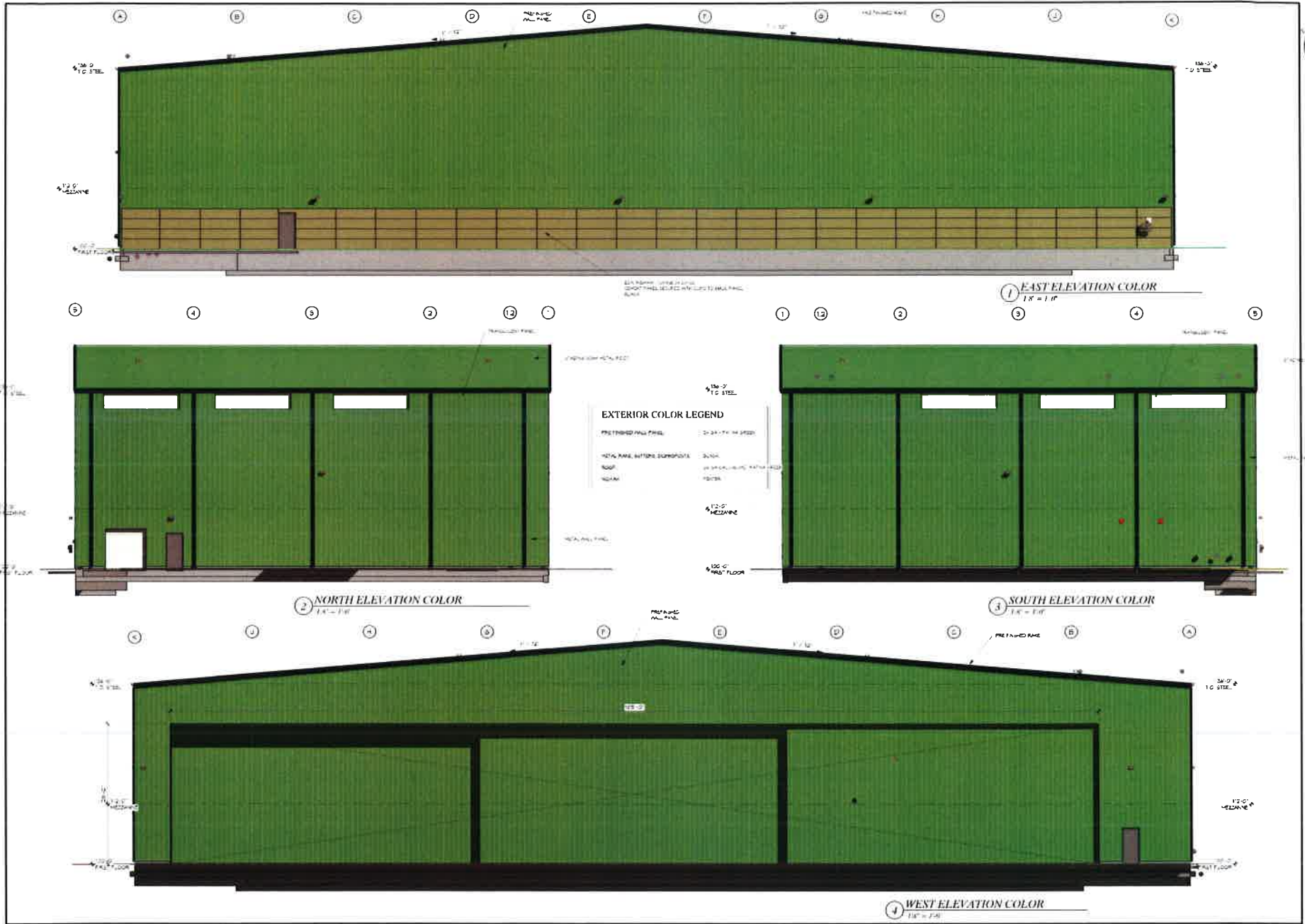
VBT East Hangar, is about ready to break ground. This was previously approved by the board. The owners wish to change the color selection, and we seek approval of the altered color scheme.
