Project on hold due to legal issues

Pedestrian Bridge North of Dam – Wishing Springs Trail to Bella Vista Lake

The tunnel has been built and project to be completed when interchange opens

Eco-Counter

Installation will be in next 60 days at that time will be complete and operational

28th Street

Survey is in the process and will take about one month to complete

Durham Park

This project is complete and will be open in next few days

Quilt of Parks

Design Workshop is in the design process on Promenade, Dave Peel and Commons

Downtown Activities Center

Outgrowing the space and plan to expand later this year

Slaughter Pen – Emergency Access

Currently in the design process

Orchards Park Dog Park

Preparing for bid as soon as possible with goal of opening in summer 2021

Bentonville Community Center

Pool heaters will be installed in a couple of weeks with completion by February

Life expectancy of flooring around pool is usually around seven years

This resurfacing will be required soon
