06-01-2020 – David Wright reported that a plan is in motion including advance warning beacons, and more crosswalks, but need another month to get the plan together and find funding for what they would like to do. All committee members in agreement to table this matter until the July, 2020 meeting.

- a) DBI is requesting the attached street closures (See Map) for the following dates 06-05-2020, 07-03-2020, 08-07-2020, 09-04-2020, and 10-02-2020, for First Friday event dates. We are expanding the footprint to include NE "A" from NE 2nd Street to NE 3rd Street (Lawrence Plaza). The majority of streets will close at 6:00 am, with Legion Lane and a portion of NE 2nd Street to Legion in order to accommodate Arvest Bank and the County Judge's Chamber (Old Post Office). Roads will reopen by 9:00 pm.

06-01-2020 – David Mills said that he has evaluated putting a crosswalk in near Glenn Road, and that it is not a good area to do that. The Street Department is, however, making improvements to the sidewalk and will be installing a cross walk North to South at Featherston Road and 28th Street. Cindy Acree made a motion to decline the crosswalk near Glenn Road, but approve the improvements and crosswalk at Featherston and 28th Street. Motion approved.

06-01-2020 – David Mills, Sign Technician, inspected this area and stated that everything is where it needs to be, with the exception of speed limit signs. He also checked the area the applicant said a vehicle parks and makes it hard to see. Mr. Mills indicated that he could see the area with no problem. There is a ton of utilities in that area. Even if he moved the sign a little, it

would not make a difference. He could see the sign. Motion by David Mills to install 25 mph speed limit signs from SE 3rd to SE 8th Street. Second by Cindy Acree. Motion approved.

III. ADDITIONAL ITEMS:

Beverly Shepherd, Administrative Assistant, received an email (attached) from Ms. Kerperien regarding putting a crosswalk near NE 11th Street (Rice Road) to cross Central Avenue/Hwy 72, and brought it to the Committee's attention. Ms. Kerperien and her son would like to be able to access the sidewalk on the south side to ride to the west and more easily and safely access Tiger Blvd and the trail systems Bentonville has to offer. She indicates that there is no good way to do that from the north side of the highway.

06-01-2020 - The Committee discussed and felt that this would be too dangerous a place to install a cross walk, since it is not a controlled intersection. They could not safely do that. In addition, this area is under the jurisdiction of the State Highway Department.

The Committee did say that the area is changing all the time, and that it might be a possibility in the future, but at this time they would not approve a crosswalk at this location, if application was made.
