

# FIRE HYDRANT METER SERVICE CONTRACT

The undersigned, hereinafter called Customer, requests the Bentonville Water Utilities Department, hereinafter called City, to furnish a fire hydrant meter as follows:

Customer agrees to pay **\$150.00** deposit (refundable) plus a **\$20.00** service charge (non-refundable) for this service, for a total of **\$170.00** (due now). If Customer has an outstanding balance with the City, the outstanding balance must be paid in full before meter will be set.

Said meter shall be provided to Customer on a month to month basis. At the end of each month the Customer must contact the City to extend the contract for another month. If Customer fails to make a request and/or fails to pay applicable fees then the meter shall be removed. An account with a balance over 90 days will be considered delinquent and the meter will be removed until account is paid. Customer agrees that all extensions of service shall be governed by the terms of this agreement, and that the initial sum of \$150.00 shall remain on deposit for the duration of this agreement and any extensions of service.

Customer agrees to pay **\$10.04** per thousand gallons and a **\$5.00** per day rental fee for each day or portion thereof the meter is in the use of the Customer. **Daily rental shall accrue until the customer requests the City to remove the fire hydrant meter.** Request for curtailment after 12:00 p.m. shall incur an additional day rental fee. The Customer also agrees to pay an additional **\$20.00** connection fee for each time the Customer request relocation of the meter. There will be no charge for removing the meter.

## **Inclement Weather Clause**

Per agreement with the fire department, the Customer agrees to turn the fire hydrant off using an approved hydrant wrench to disconnect and drain the hydrant meter during the months of November through April if the temperature falls below freezing. If the meter is not disconnected it must be adequately protected using an approved insulated covering. **Please note: The fire hydrant must not be covered.** Customer agrees to maintain the hydrant meter in reasonable condition and to safeguard the meter against damage or loss. In the event of damage to the fire hydrant meter, the Customer agrees to pay for all associated damages to the fire hydrant meter, brass valves, or fire hydrant **before** another fire hydrant meter will be set.

**Customers abusing these privileges will be subject to refusal of fire hydrant meters in the future.**

Customer agrees to indemnify the City against all claims due to water pressure, purity, or volume or due to damage to private or public property arising from the use of the fire hydrant meter.
