



OFF-PREMISE (RETAIL) ALCOHOLIC BEVERAGE PERMIT

Dear Owner/Manager:

Thank you for choosing the City of Bentonville for your establishment. This letter is a brief summary of the responsibilities for applying for and maintaining your Off-Premise (Retail) Alcoholic Beverage Permit based on Arkansas State Law 3-5-212:

- 1) It provides for an annual permit to be issued by the City Clerk. The cost of the annual permit is \$15 plus \$5 per thousand dollars of gross sales in excess of \$1,000. Since year 1 will have no sales history, the initial fee will be \$15.00. Subsequent years will be based on 12 months of sales in a calendar year. If the fee is not paid, we are required to report to the director of ABC.
- 2) The attached application will need to be completed in full and returned to the below address.

- 3) Include a copy of your current permit issued by the State of Arkansas.
- 4) Renew each year by June 30th using the same application and include a copy of your current permit for the new renewal period.

According to the Alcohol Beverage Control website: "**Beer**" is defined as any fermented liquor made from malt or any substitute therefor and having an alcohol content of not in excess of five percent (5%) or less than one-half of one percent (0.5%) alcohol by weight and "**Light Wine**" is defined as the fermented juices of grapes, berries, or fruits and any other mixture containing the fermented juices of grapes, berries, or fruits, having an alcoholic content of between one-half of one percent (0.5%) and five percent (5%) alcohol by weight.
